Hosted by the Northern Piedmont Community Foundation, the *Emergency Response Fund* will provide flexible resources to organizations in Culpeper, Fauquier, Madison and Rappahannock counties helping to alleviate the effects of the Covid-19 pandemic. The Fund will operate in partnership with local governments, schools, other foundations and the private sector to address current and emerging needs and strategically fill gaps in support.

To apply: Compose an email letter addressed to NPCF, *Emergency Response Fund*, send to: need@npcf.org

In your letter, please provide:

- Your organization's name, EIN number, address and contact information.
- Please address the short-term implications on your organization due to the Covid-19 crisis and the anticipated long-term, 3 months or more, effects on your organization.
- Provide a simple budget that highlights the need for funding.

Funding amounts will vary and NPCF understands that your funding needs may change. If awarded, you may reapply in one month or sooner if there are extenuating circumstances.

Funding requests will be responded to immediately or within one week of your request. You may email jbwilson@npcf.org or call 540-349-0631, ext.1 or 3 to discuss or for questions. Because this is an evolving situation, award amounts and further criteria will be added as needed. This fund has been established to support critical needs in our communities due to the Covid-19 crisis.
